RECOMMENDED RESOLUTION: Resolved that the Board of Governors approve the FY 2009 Expenditure Schedule for submission to the State Offices.

BACKGROUND: A proposed FY 2009 Expenditure Schedule has been included for your review.

Council staff is requiring the submission of the document by May 1, 2008. The Budget is based on projected Income and Expense for the last quarter.

PROPOSED SALARY INCREASE

ITEM: Salary Increase for Employees

COMMITTEE: Committee of the Whole

RECOMMENDED RESOLUTION: Resolved, that the Board of Governors review the implementation plan for the salary increase for employees.

BACKGROUND: Salary increases were appropriated by the West Virginia Legislature for inclusion in institution budgets. Eastern received a total of \$40,548.00. Increases are based on Eastern's current salary plan which states:

Move all current eligible classified employees at a uniform percentage of the distance from their current salaries toward salaries at the proper step for their respective classification and pay grade or at a uniform number of steps. Percentage or number of steps will be based on total funds available for salary increases; comparability to movement at peer institutions and the relationship of salaries of current employees to new hires.

Effective date: July 1, 2008.
