Call to Order: The meeting was called to order at 12:05PM. Present were Dr. Terrell, R. Tissue, S. Staley, JR Helmick, G. Greenwalt, M. Chambers, C. Hakala, T. May, and M. O'Leary, recorder. Absent were D. Bean, D. Lambert, F. Shanholtz, G. Sponaugle, and L. Godlove. Guest was Penny Reardon.

Minutes were approved on a Greenwalt/Hakala motion. Motion carried.

#### Presentation:

A. CMT Empowering Education – The Board of Governors viewed the video featuring Dr. Terrell and EWVCTC students.

#### Welcome:

A. Theda May, Student Representative – Dr. Terrell introduced Ms. May and R. Tissue welcomed her to the Board of Governors. Ms. May is a resident of Moorefield, is president of the EWVCTC Student Government Association, and took her Oath of Office on June 15, 2016.

  - Updated policy was approved on a Greenwalt/Helmick motion. Motion carried.
- B. FY 17 Board Calendar

  FY 17 Board meeting calendar was approved on a Greenwalt/Staley motion. Motion

- C. Program Reviews: A.A.S. Occupational Development; A.A.S. Technical Studies, CAS Technical Studies

Following an overview from C. Hakala, Program Reviews were approved on a Greenwalt/Chambers motion. Motion carried.

D. Compact

Following an overview by Dr. Terrell, EWVCTC Institutional Compact was approved on a Helmick/Staley motion. Motion carried.

### Informational Items:

- A. WV Council for CTC Education meeting July 15 (Budget, Tuition & other agenda items)
  - Dr. Terrell discussed the recent emergency meeting of the Council. While the Council did not approve a 12% tuition increase for FY 17 as requested by EWVCTC, the Council did approve a 9% tuition increase.
- B. FY 17 Budget
  - Dr. Terrell and P. Reardon presented the revised FY 17 budget based on the 9% tuition increase. P. Reardon indicated that the revised budget reflects a 4% cut; reserve will be at 27%; and a mid-year budget cut can be expected. The 9% tuition increase and revised budget was approved on a Greenwalt/Chambers motion. R. Tissue indicated that, while approving the new budget was not an agenda action item, the budget was posted as an informational item on the agenda. This action on an informational item was approved on a Greenwalt/Staley motion. Motion carried.
- C. FY 16 Tuition Waiver report

  Dr. Terrell indicated that the employee freeze on tuition waivers remains in place,
  and the focus will be on student scholarships.
- D. Tobacco Free Zone-July 1, 2016 The Board of Governors approved policy has gone into effect.
- E. 2014-2015 Annual Report
- F. Adult Basic Education update Dr. Terrell indicated that Adult Basic Education is now known as Adult Education. EWVCTC was informed in July 2015 that it is no longer a fiscal agent of Adult Education. Adult Education will transition from the Tech Center to South Branch by September 1, 2016. Space in Tech Center will be made available for public use for a fee.
- G. Fall Enrollment update Dr. Terrell reported 205 FTE's registered for the fall semester. Budget is based on 350 FTE's. Efforts continue to enroll more students, and final numbers will be presented at the October Board of Governors meeting.

## **Board Chair & Committee Reports:**

- A. WV Board of Governors Association R. Tissue indicated that, as Chair of the WVBOGA this year, he has invited Chancellor Sarah Tucker to the association meeting later this summer. EWVCTC BOG members should let R. Tissue know of interest in attending.
- B. Classified Staff updates-Laurel Godlove Ms. Godlove was absent no report available.
- C. Faculty updates-Curtis Hakala C. Hakala announced that two new faculty positions have been filled via grant funding from DHHR and Perkins. C. Hakala, B. LaVorgna, and D. Phillips will attend the Noel-Levitz conference at the end of July. Tutor.com has received a 90% approval rating from EWVCTC students.
- D. Student updates-Theda May T. May indicated that Open House is scheduled for August 1; August 15 is the first day of classes; and an outdoor movie night will be held on August 19. More events will be scheduled once students return for the fall semester.
