

 Call to Order – The meeting was called to order at 12:03pm. Present were Dr. Terrell, R. Tissue, G. Greenwalt, D. Bean, S. Staley, Jr. Helmick, M. Chambers, C. Hakala, A. Degnan, and S. Scamehorn. Guests present were C. Hedrick, J. Strawderman, G. Shields, M. Wilson, L. Koontz, and S. Smoot.

3. Presentation:

Audit Report (via phone at 1:30pm), Marie Long, Suttle & Stalnaker, CPA's – M. Long and S. Murphy shared a PowerPoint presentation on the Audit Report with the Board of Governors. Bound copies of the Audit report were distributed to Board members. On a Greenwalt/Chambers motion, the Audit Report was accepted with all in favor.

Superintendents, Monica, and Lacey

R. Tissue began the discussion by reporting that funding and enrollment are Eastern's biggest concerns. C. Hedrick reported that his biggest challenge is the recruitment of qualified teachers and staff. The state level of pay is approximately 10% below surrounding counties. Benefits have been eroding, and financing is based on student population. Opportunities include good test scores and good partnerships, all without a levy that other counties assess. J. Strawderman reported that Hardy County has the highest number of non-certified substitute teachers this year. Dr. Terrell reported that he is considering using a live stream video conference platform to teach courses. The Benedum Foundation would like to expand dual credit possibilities. Math was raised as an

issue for many students, and it affects success in other courses. J. Strawderman reported that most high school students are undecided in terms of their post-high school plans, but the trend of going to college as an expectation is declining. C. Hedrick reported that, in order to connect with students, Eastern needs to connect its students with jobs. Both J. Strawderman and C. Hedrick indicated that Eastern is doing well with dual-credit courses, and that the college could do better at building relationships with vo-tech centers, and matching high school class schedules with Eastern's class schedule. R. Tissue indicated that the CTC system views vo-tech centers as competitors. In Florida, there is a model that allows all high schools students to graduate with an Associate's Degree. S. Staley reported that some counties require a higher number of credits to graduate than what is mandated by the state. Dr. Terrell reported that Eastern wants to keep an open dialogue with county school systems. J. Strawderman reported that M. Wilson and L. Koontz do a very good job. R. Tissue thanked C. Hedrick and J. Strawderman for their insights and time.
