### **Nursing Adjunct, Nursing Simulation**

**Position:** Nursing Adjunct Faculty; Temporary, Part-Time position; Not Benefits Eligible

**Location:** Moorefield, WV Headquarters and Grant Memorial Hospital

**Schedule:** The schedule will be established each semester by the Eastern Nursing Program Director. Not to exceed 24 hours per week.

**Hourly Rate of Pay:** \$25 per hour

#### **Responsibilities:**

- Perform professional supervisory nursing practice in the care of the physically and mentally ill.
- Work involves supervising the provision of quality nursing care and clinical simulations given at a facility.
- Responsible for maintaining the quality and adequacy of nursing practice for recognizing and assisting in solving professional, administrative and supervisory problems in an assigned area.
- Position exercises considerable judgment in applying professional knowledge in teaching and solving nursing problems within established policies and practices and is reviewed by the supervisor through conferences, reports and observation of results obtained.

#### **Minimum Qualifications Requirements:**

*Education* – A Bachelor’s Degree in Nursing with a minimum of 2 years of experience in nursing per WV Code 30-7-5a.

*Experience* – Evidence of current experience in nursing practice and education sufficient to demonstrate professional competence. Licensed as a registered professional nurse in West Virginia.

*(b) Part-time nursing faculty members shall:*

*(1) Have a bachelor’s degree with a major in nursing and at least two years of direct patient care experience in nursing;*

*(2) Have credentials which verify status as a registered professional nurse in West Virginia.*

*The board may grant an exception to the requirements in §30-7-5a(a) and §30-7-5a(b) of this code for faculty members who have qualifications other than those set forth in these subsections which are acceptable to the board.*
