Staff – Tiffany Sentman – *Dominic Phillips redesigned the Full-Time and Part-Time faculty contracts format and added the following compliance requirements:*

- 1. Move the syllabus submission date to before the start of the semester instead of at the end of the first week to correct errors.
- 2. Require faculty to submit a Section Assessment Matrix for course(s) which identifies the gradebook items that will be used to measure student progress against the course's learning outcomes. The matrix is available from, and returnable to, Dominic Phillips, Associate Dean of Academics and Assessment. This requirement will improve adjunct faculty who lack suitable Mastery assessment activities.
