- Fall enrollment numbers reflect positive growth. Working on a deeper program analysis with J. Draper. Will share this information with the Board of Governors once it is available. Feds will be looking at student loan debt and whether students are getting jobs.
- \$170,000 grant approved for the AI program. Still need HLC approval.
- Was in Romney yesterday with L. Arbaugh. Met with the Mayor, Hampshire County Schools Superintendent, and a representative from the WV Schools for the Deaf and Blind. It was a very productive meeting.
- Received word that the Governor's Office will be cutting appropriations for all state agencies. Unclear how it might impact the funding formula. Hope to learn more at WV Chamber of Commerce annual meeting next week.
- Working on an AI presentation for Eastern employees and the Board of Governors. AI will significantly impact higher education over the next five years. There will be a tipping point with positive and negative outcomes.
