You must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the Financial Aid Office. If you are a dependent student, at least one parent must sign this worksheet. Based on your answers on this worksheet we may ask for additional information. If you have questions about verification, contact our office as soon as possible so that your financial aid will not be delayed.
