## Strategic Plan 2015 – 2020 Reports

## Dr. Thomas Striplin, President

- WV funding model formula The WV Legislature wants a funding formula proposal this legislative session. Participated in a workshop that reviewed the Tennessee model. Chancellor Tucker is looking to mold it into a plan for WV. Incentives for completion, retention, and number of credits earned as a function of the type of student the institution serves will be included. Workforce is included. Need to consider what percentage of the model should be performance based, and whether the legislature would approve additional funding based on performance, without taking funds from other institutions. Another meeting is being planned.
- Federal funding of community colleges Attended a meeting with other WV community college presidents, the US Department of Education, and the Biden administration on the free community college proposal. The proposal includes first dollar in and block funding to states. The federal government would provide 75% of funding, and states would provide 25%. May also include funding for workforce. If passed, it could make the WV funding formula moot. The federal proposal is for \$62 billion in funding.
- Strategic Plan Student data still needs to be added to the SWOT Analysis. Reviewed the SWOT Analysis slide deck with the Board of Governors. Focus Groups will be held in October to discuss strategy. Hope to have a draft Strategic Plan that the Board of Governors can review at their November 2021 meeting. The Strategic Plan needs to be aligned with the budget, needs to be measurable, and needs to be an inclusive effort.
- Weimer & Mustang Met with D. Weimer and learned that the auto industry is struggling. Plan is to provide a Mustang to Eastern on a no-cost, 3–6 month lease. The

Mustang wasn't meant to be a donation. Need to obtain vehicles for the Auto Tech program as donations to the Foundation. For now, the Mustang is off the table, and Dr. Striplin and G. Greenwalt will consult with S. Arbaugh.

- Covid update *Mostly under control, although one program is now virtual.*
- HVAV update Two meetings on HVAC issues in the past month with another one planned, Issues are being addressed. Control system will also be fixed and funded through the capital budget.
- College budget and planning *See above*.
- HLC letter and distance education *The US Department of Education rescinded a "Dear Colleague" letter on distance education. Eastern is working with HLC to submit a distance education inventory.*

Dr. Striplin also reported that he and Dr. Terrell have been in touch regarding the federal earmark; M. Webb is working on CDL challenges; need to decide what to do with two old fleet vehicles; Executive Dean position is on hold; and Title IX training is taking place.
