Dr. Terrell reviewed the enrollment data with the Board of Governors. COVID-19 is negatively impacting enrollment at colleges and universities around the country. Eastern is evaluating the use of mini-grants to boost enrollment using CARES Act funding. Will have \$288,000 in CARES Act funding to help close budget gaps. Taking fall classes one day at a time. Wind Tech, Auto Tech, and Nursing classes will meet in smaller groups, with the use of PPE and social distancing. S. Van Meter offered to send an email blast to Hardy County juniors and seniors regarding early entrance classes. Eastern's protocols will need to match high school protocols.
