Call to Order

The meeting was called to order at 12:00pm. Present were G. Greenwalt, Dr. Striplin, S. Arbaugh, M. Chambers, S. VanMeter, A. Blackwood, J. Kubeika, S. Alt, S. Michael, A. Degnan, and T. Southerly. Guests included M. Blizzard, A, Frey, M. Wilson, and T. Branson.

Presentation/Discussion/Professional Development

Annual Financial Aid Presentation – Mary Blizzard, Director of Financial Aid and Alicia Frey, Associate Director of Financial Aid, via Zoom.

Higher Education Institutions continued to operate the 22-23 aid year under the national emergency declaration due to COVID-19. The Declaration was ended April 10, 2023 but, many flexibilities are expected to continue through the end of the aid period after the national emergency is ended. The Declaration allowed our students to continue various flexibilities which included:

- Suspension of income verification requirements except in cases of conflicting information
- Allowance for Emergency SEOG to students affected by the COVID-19 Pandemic
- Mandatory forbearance of student loan payments continues through at least June 2023
- Cohort Default Rates remain low as a result

Financial Aid Processing 22-23

- Eastern has 179 Degree Seeking students enrolled in Spring 2023
- Of those students -172 filed the FAFSA, 160 or 93% were determined to be aid eligible and received some offer of aid
- For the 22-23 aid year Eastern has paid 130 students \$511,283 in Pell Grants
- For the 22-23 aid year Eastern has paid 72 students \$21,500 in SEOG Grants (including emergency SEOG)
- For 22-23 Eastern has paid 95 students \$202,017 in WV Higher Education Grants, 40 students (up from 24 in 21-22) \$85,713 (\$34,100 in 21-22) in WV Invests and 5 Promise students \$10,560

Future Activities and Enhancements

- 23-24 Aid processing started in October 2022
- We have received 313 ISIR's to date which is up from 264 this same time last year. This is following a trend of higher FAFSA completion numbers statewide.
- Maximum Pell increases in 23-24 to \$7,395 annually, up from 22-23 which is \$6,895 annually

- The 24-25 FAFSA application should be available in December 2024 (normally available in October each year)
- 24-25 The FAFSA simplification changes will include:
 - The Student Aid Index (SAI) will replace the Expected Family Contribution (EFC) on the FAFSA form. Students and families will see a different measure of their ability to pay for college and experience a change in the methodology used to determine aid.
 - The SAI will expand the Federal Pell Grant to more students and link eligibility to family size and the federal poverty level. New eligibility formulas and funding are estimated to increase Pell Grant recipients by nearly 15%
 - O Students who are homeless, orphans, former foster youth, or who have other unusual circumstances that prevent them from providing parental information on their FAFSA form, will benefit from simplified questions and processes that more efficiently determine their independent status
