Board Chair-Greg Greenwalt - FY 23 amended Presidential Salary Increase + \$47.58 – G. Greenwalt reported to the Board of Governors that, due to a minor mathematical error, Dr. Striplin's FY 23 salary had been increased by \$47.58 which did not require Council approval. G. Greenwalt reminded the Board of the Farm to Table Dinner on June 29 and that 85 tickets have been purchased to date. The Board of Governors introduced themselves to T. Southerly.

Finance & Facilities – Trina Branson – Auditors will be on campus the week of July 11. Should wrap-up audit by September 6, 2022. Vacant Cashier position has been posted – 15 applications received and position has been offered and accepted. Working with L. Guinn on 3 – 5 year budget projections. ABE will start to pay \$500.00 per month in rent for Eastern office space beginning on July 1. Two CDL tractors and one trailer have been purchased. Employee raises are 5.44% for FY 23.

- 1. Dr, Striplin attended the President's Retreat hosted by Chancellor Tucker last month. Many potential new initiatives were discussed.
- 2. The possible aviation technology program is making good progress. The feasibility study team will be arriving later this month.
- 3. Deferred maintenance funding from the state is possible.
- 4. The Title III Grant is going well.
- 5. Eastern received a nursing grant of \$275,000. Allows for increased enrollment from 20 students per cohort to 30.
- 6. CDL grant was received, and matched, for a total of \$200,000. Allows for the purchase of two tractors and one trailer. Trailer will be co-branded with Pilgrim's.
- 7. New workforce employee coming on board to develop microcredentials in hospitality and solar technology.
- 8. Dr. Striplin met with the lawyer representing Eastern in a legal case. The lawyer will come to campus in July to interview employees familiar with the situation.
- 9. Dr. Striplin has been attending many meetings, conferences, and retreats.
- 10. Eastern will be a sponsor for Grant Memorial Hospital's Golf Tournament fundraiser.
