9 credit hours with 5 lecture hours per week. The remaining 4 credit hours were in laboratory or clinical rotations with a 3:1 ratio. Therefore, the laboratory/clinical hours equaled 12 contact hours per week. The course is a mandated course in the nursing curriculum and students must make a "C" or above in the course in order to progress in the program. Pre-requisites include NU 132, NU 133, and NU 134 and must be taken concurrently with NU 142 and NU 143.

The previous assessment was the first cohort that had the mandated benchmark score of 800 or above. They did not meet the benchmark for Spirit of Inquiry on the HESI exam, but Spirit of Inquiry was met on the CPET and class assignments. All of these outcomes will be measured in the progression of the nursing curriculum.

Assessment Methods

The student took 10 exams worth 445 points, quizzes worth 45 points, assignments (case studies and discussions) worth 25 points, and the HESI exam worth 100 points. The clinical component was assessed with a clinical performance evaluation tool (CPET). Other written assignments in the clinical rotation are simulation in the laboratory setting and report received and given (SBAR), and daily assessment notes. The exams are validated by at least two nursing faculty members after an analysis of each question All exams were on Blackboard. In order to make a "C" or above, the students had to answer 80% or more of the exam questions, pass the clinical portion which is measured by the CEPT, and make an 800 or above on the HESI exam.

17 of 20 students successfully passed the course with a "C" or above by successfully completing the clinical component (According to the CPET 100%), having an 80% on the combined exam scores which included the HESI composite score and an 800 or above on the HESI exam (84%). If the students were not successful on the first HESI exam, they were allowed to take a second version which was comparable. Five students had to take the second exam due to not meeting the benchmark of 800 or above. Three students needed to take the HESI a second time due to not having an 80% in the class with the first composite HESI score. Only seven students took the second version of the HESI. One student opted to forgo the second version. Students have to pay for the second version, it is not included in their package, and they knew they would not pass the class. All seven students scored an 800 or above on the second version of the HESI. Two students did not have an 80% in the class with the HESI composite score. This HESI exam previously was developed for the WVCADN and that group has since dissolved. This class is the first that had national averages to compare. To ensure that all the course objectives, the general education values and the Nursing SLOs were measured, the exam questions, case studies, CPET (Clinical Performance Evaluation Tool), and concept maps were aligned with the objectives.
