Course Role in the Curriculum

This course is designed to introduce fundamental nursing knowledge to the nursing student. It provides the knowledge for them to assess and document their findings within the hospital setting. Emphasis is placed on detailed history taking, differentiation, interpretation and documentation of normal and abnormal findings. The student will be introduced to normal lab values and basic diagnostic procedures. This course is designed to assist them to develop skills in history takin, psychosocial and physical assessment. This course includes lecture, discussion, lab skills, documentation, physical assessment in the class setting and the hospital setting.

8 written exams were administered with a total of 595 questions which included 4 quizzes worth 20 points. The final was the HESI exam which was worth 100 points. The HESI exam is an assessment test that was made for this course by Elsevier and it consisted of 75 questions and was utilized as the comprehensive final. The conversion score was averaged into final grades and the students had to get 80% or more of the available points as one component of passing the course with a "C" or above. The students had to achieve the 750 benchmark on the HESI exam. Two attempts were allowed to achieve the benchmark and the conversion score required to have an 80% average overall. In addition, the students had to successfully pass the clinical component which was assessed on the Clinical Performance Evaluation Tool (CPET). Each student had to successfully perform multiple skills in the laboratory prior to the clinical rotations. In the clinical rotations, Jill Landis and Heather Barger monitored and guided the students in the hospital setting. The students were also required to submit paperwork for the laboratory days and the clinical rotations which included daily assessments with notes. In the nursing laboratory, the students completed nursing care plans with case studies. They had to complete a math competency exam with a score of 90% or higher which included calculating drug dosages, intravenous drip rates and Intake/Output. Each of the questions on the exams was validated by at least two of the nursing faculty. If more than 33% of the class missed any one question, the question was evaluated.

All 20 students successfully demonstrated technical skills in the laboratory and successfully completed their clinical rotations. In addition, 95% passed the theory portion with an 80% or above. One student met the 750 bench mark but the composite score was too low and brought her average down to 79.8% and per program and WVCADN policy, the grades are not rounded. Five of the twenty students had to take a second version of the HESI because they failed to make the 750 benchmark and four of those were successful the second time. 100% of the students passed the math competency exam by answering at least 90% correctly the first time the test was administered. The class range for the HESI score was 571-1003 and the class average was 794 on the first attempt. The average for the five students who had to take the second version had an average of 866.

19 of 20 students obtained an 80% on the exam questions which included the HESI exam. Each of the other questions was worth 1 point each but the HESI exam had 75 questions which were worth 100 points. Although 100% of the students met the 750 benchmark on the HESI exam, one student's composite score was too low and she did not make an 80% in the class. 20 of 20 successfully completed the clinical portion of the class. 95% of the students successfully completed the theory portion and the clinical portion to make the mandated "C" or above to continue in the program.
