1. Purpose of the RFP

Eastern WORCS is soliciting proposals from qualified contractors, environmental planners, ecological engineers, and remediation specialists to support all planning activities.

2. Background

This project addresses nitrogen pollution from poultry CAFOs in the Potomac Highlands and builds a scalable model for ecological restoration and economic revitalization. The work plan identifies responsibilities, including developing stream restoration models, supporting economic assessments of nitrogen remediation, and contributing to the planning of the circular food economy.

3. Scope of Work

A. Model Framework for Stream Restoration as Remediation

Contractor will:

- 1. Designing a model framework for stream restoration that documents and forecasts nitrogen reduction impacts.
- 2. Identifying restoration techniques suitable for poultry-impacted headwater systems.
- Developing environmental baselines and projected outcomes for restored stream segments.
- 4. Integrating restoration modeling into pollution reduction planning.

B. Techno-Economic Analysis of Nitrogen Remediation Strategies

Scope includes:

- 1. Supporting the analysis of costs and benefits associated with stream, soil, and water remediation.
- 2. Modeling economic viability for long-term maintenance of remediation systems.
- 3. Providing environmental and economic input for the project.

C. Regional Eco-Food System Economic Modeling

Contractor tasks:

- Contractor will develop planning analyses for a regional circular food economy, linking nitrogen reduction to market-based value.
- 2. Providing modeling inputs that reflect how improved ecological conditions can support premium pricing of eco-certified agricultural products.
- 3. Supplying ecosystem-services assessments used in "paid-for-performance" market design.

D. Environmental Analytics & Evaluation Inputs

Contractor responsibilities include:

- 2. Supplying indicators for water quality, soil impacts, and ecosystem function.
- 3. Delivering environmental data structures that will feed into the project's evaluation.

4. Deliverables

Contractor(s) are expected to provide:

- 1. Stream restoration planning frameworks
- 2. Baseline and projected nitrogen-reduction analytics
- 3. Remediation modeling documents (soil, stream, and water)
- 4. Techno-economic assessment materials
- 5. Circular food-economy ecological integration memos
- 6. Participation in meetings and technical reviews

Deliverables may be submitted as Word documents, PDFs, spreadsheets, modeling files, or environmental diagrams.
