**Project:** Planning a Profitable Circular Food System by Reducing Airborne and Effluent Nitrogen Discharge to the Chesapeake Bay Watershed

## 1. Purpose of the RFP

Eastern WORCS is seeking qualified contractors, consultants, and technical partners to support a set of planning tasks for the EPA Region 3 Thriving Communities Tier II project.

#### 2. Background

The project focuses on reducing nitrogen-related air, water, and soil pollution from poultry CAFO operations in the Potomac Highlands and creating an economically viable circular food system. Activities include planning air/water filtration systems, modeling manure management practices, developing nitrogen reduction accounting, creating circular-economy frameworks, and designing new workforce training systems.

## 3. Scope of Work

#### A. Nitrogen Pollution Abatement - Filtration & Systems Planning

Contractor will support planning and design activities, including:

- 1. Technical plan for air and water manure filtration systems for a model CAFO.
- 2. Review of schematic tracing for nitrogen pollution cycles (air & water).

## B. Solid/Liquid Manure Management - Profitable Practices Planning

Scope includes:

- 1. Planning improved nutrient management practices for manure land application.
- 2. Participating in improved equipment & field practice model development.

## C. Profitable Remediation Accounting - Model Framework Development

Contractor responsibilities:

- 1. Develop a model framework connecting interventions to nitrogen crediting systems.
- 2. Produce planning components that quantify reductions monetizable through credits.
- 3. Coordinate with economic modeling partners on pollution-reduction valuation.

### D. Workforce Development Planning - Technical Training Alignment

Contractor tasks:

- 1. Survey existing workforce curriculum, including:
  - CAFO management
  - Manure management

- Air/water remediation
- 2. Identify gaps in curriculum and required competencies.
- 3. Draft recommendations for new micro-credentials, certifications, and training modules aligned to the installation and maintenance of:
  - Air filtration systems
  - Water filtration systems
  - Manure management technologies
  - Nitrogen remediation systems
