

1. Call to Order: The meeting was called to order at 12:02pm. Present were Dr. Terrell, R. Tissue, S. Staley, G. Greenwalt, M. Chambers, D. Bean, F. Shanholtz, C. Hakala, L. Godlove, T. May, and M. O'Leary (recorder). Absent were Jr Helmick, D. Lambert, and D. Sponaugle. Guests present were P. Reardon, M. Wilson, and M. Blizzard.

The meeting began with a Hardy County Chamber of Commerce photo opportunity. Alice Shanks, Executive Director of the Chamber, presented Dr. Terrell and the Board of Governors with a Proclamation from Governor Jim Justice recognizing Eastern as the Hardy County Chamber of Commerce 2017 Non-Profit Organization of the Year Award recipient.

2. *Action Items:

a. Approval of the Minutes – Meeting of March 22, 2017

On a Greenwalt/Shanholtz motion, the minutes were approved with all in favor.

- b. FY 18 budget discussion
 - P. Reardon presented different budget scenarios to the Board of Governors. With the state budget still in limbo, forecasting the FY18 budget remains difficult. There are many challenges including enrollment, tuition rates, expenses, and the state appropriation. Dr. Terrell indicated that the Board's Finance Committee will meet once the state budget situation is more stable, and that South Branch has withdrawn from the Cosmetology program. Several Board members reiterated the importance of increasing enrollment in order to increase tuition revenue.
- 3. Guest Speaker:

a. Marlena Brown – Blackboard Data Analytics (via Skype)

M. Brown joined the meeting at 12:05pm via a web link. She presented a Powerpoint to the Board of Governors on the different capabilities of Blackboard Data Analytics (BBDA), including customized data reports and dashboards. R. Tissue commented on a specific slide that showed an enrollment drop-off in "employment-age" students, indicating that this type of data will be very helpful in helping to reverse enrollment declines. D. Bean asked how much BBDA costs. Dr. Terrell indicated that the cost was covered by a Bridging the Gap grant. M. Brown thanked the faculty and staff at Eastern for being BBDA "superstars". Her presentation ended at 12:40pm.

b. Financial Aid Report – Mary Blizzard and Monica Wilson

M. Blizzard and M. Wilson presented a Powerpoint presentation to the Board of Governors which indicated progress made in financial aid practices, and the challenges that remain. M. Blizzard indicated that a consistent application of policies, tiered packaging, and better communication with students have all had positive outcomes. M. Wilson indicated that the default rate remains a concern, but better financial aid counseling and financial literacy education should help improve the default rate. M. Blizzard reported that official financial aid data generally lags for three years, so that improvements made this year may not be reflected in Eastern's numbers for another three years. She is confident that the college is moving in the right direction.
